- All vendors must have a seller's permit.
  - <sup>1</sup> Fremont resident and business vendors: Fremont Business Tax permit is required. Obtain thru City of Fremont.
  - <sup>2</sup> Non-Fremont resident or business vendors: Also submit a Fremont *Special Event Business Tax* form (\$5/day) **with** your MSJ Chamber application to us, **See separate form.**
  - Live plant vendors shall must have documentation from the Dept of Agriculture of the company merchandise is purchased from.
- <sup>3</sup>Vendors selling consumables are required to follow current Alameda County Dept. of Env. Health Rules and obtain a Temporary Food Facility Permit (TFF). <https://deh.acgov.org/operations/tff.page?>
- Food Truck vendors are required to follow current Alameda County Dept. of Env. Health Rules and/or obtain a Mobile Food Facility permit (MFF). <https://deh.acgov.org/operations/mff.page?>



- Electricity is NOT available. Small, quiet generators are acceptable (Honda)
